**Title:** To Designate Branson, Missouri as the location for Reunion 2010

# **Text of Motion:**

I move that the Board designate Branson, Mo as the location for our reunion from 20-25 October 2010 and engage Pam Brown of Gatherings Plus (see paragraph. 3 below) to make all arrangements identified above, and designate George Harmon as our "boots on the ground" reunion chairman.

# **Rationale or explanation:**

A summary of my trip report to Branson with Alicia and George Harmon follows:

Wayne Brunz (535, 67) told George Harmon that he went to a B-52 reunion in Branson which was arranged through Pam Brown (417-338-4048) of Gatherings Plus (<a href="http://www.gatheringsplus.com/">http://www.gatheringsplus.com/</a>). Wayne said that the arrangements and services provided by Pam and her staff at Gatherings Plus (GP) were **OUTSTANDING**. George arranged for us to meet with Pam and the hotel contact point (Kristie) at Pam's recommended hotel, Lodge of the Ozarks (<a href="http://www.lodgeoftheozarks.com/">http://www.lodgeoftheozarks.com/</a>).

George Harmon (537, 69) has agreed to be our reunion planner and "boots on the ground" for a Branson reunion. He lives in Springfield, 40 minutes away.

9 Dec 2008 update: Pam Brown has obtained the commitment of the Lodge of the Ozarks to provide the banquet room, War Room, and Memorabilia Room described in paragraphs 1.10, 1.11, and 1.12 above.

Wayne De Lawter, our Association reunion planner, endorsed the selection of Branson in a message to me:

#### "Pat

The hotel cost is \$6.60 less than the off-the-street walk-in rate. I imagine we could do a little better than that for 190 rooms even with all the other listed things, but frankly I don't think it is worth the negotiating and coordinating effort of any of our members. So I believe this plan that you've endorsed with that local coordinating firm is fine. It will take a lot of work off our volunteers. ... BTW, thanks for all your efforts in scouting out both Branson and Warner-Robins. Have a Merry Christmas.

### Wayne"

I conclude that a reunion in Branson in 2010 is feasible and logistics factors are favorable. Therefore, I recommend that we approve Branson as the site of our 2010 reunion with Gatherings Plus acting as our agent in Branson.
