# **Title:** Amendment to Check Writing Procedures

#### Text of Motion:

I move to revise the check writing procedures as follows:

All expenditures on behalf of the Association require prior approval, as follows: Checks under \$500, two Board members who have signature authority. Checks of \$500 and above require a motion of the Board. Expenditures for printing and mailing two newsletters and reunion flyer are excluded from the requirement for a Board motion, provided that each does not exceed \$1800.

# Rationale or explanation:

This is a routine expenditure and voting on it represents a pro forma action that really does not represent a decision that requires a vote. The amount of \$1800 represents a historical average adjusted to cover expected inflation increases. The Board must agree on changing the policy.
